An Import Export Code (IEC) is issued by India's Directorate General of Foreign Trade and is mandatory for any business to legally export goods from India. A registered IEC, alongside an active GSTIN and CIN, is the fastest way for an overseas buyer to confirm an exporter is a real, accountable, tax-compliant business. Not a one-invoice operation that disappears after the advance is paid.
